The Board of Directors of Fort Bend County Municipal Utility District No. 123 will hold a regular meeting on **Wednesday, August 21, 2024, at 9:00 a.m.**, at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2400, in the San Jacinto Conference Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.

4. Discuss outreach to underprivileged businesses.
5. TCEQ Phase II Small MS4 General Permit and Storm Water Management Plan, including status of compliance, necessary training, and public comment.
6. Review Arbitrage Rebate Report for the Series 2019A Refunding Bonds.
7. Financial and bookkeeping matters, including:
 - a. payment of the bills and review of investments; and
 - b. budget for fiscal year end September 30, 2025.
8. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
9. Discuss 2024 tax rate, set public hearing date, and authorize notice of public hearing regarding adoption of tax rate.
10. Engineering matters, including preparation of plans and specifications, approval of plans and specifications, advertisement for bids, bid review, contract award, Pay Estimates and Change Orders, and acceptance of projects, if appropriate, including:
 - a. Wastewater Treatment Plant;
 - b. Water Plant Expansion; and
 - c. Lakemont Stormwater Reuse Pump Station Rehabilitation.
11. Authorize acceptance and conveyance of easements/deeds/utility deeds, approval of abandonment of easement or facilities, and review of plans.
12. Park project and recreational facility matters, including preparation of plans and specifications, approval of plans and specifications, advertisement for bids, bid review, contract award, Pay Estimates and Change Orders, and acceptance of projects, if appropriate, including:
 - a. Creekside Park at Lakemont.
13. Review Maintenance and Capital Improvement Plan.
14. Operation of District facilities, including:
 - a. billings, repairs, and maintenance;
 - b. hearing on termination of water and sewer service to delinquent customers and for rate order violations and authorize termination of service and/or penalties;

- c. North Fort Bend Water Authority matters, including Water Provider Conservation Program updates;
 - d. amend Rate Order; and
 - e. approve Amendment to Service Agreement with Municipal District Services, LLC.
- 15. Discussion of drainage agreement with Fort Bend County Municipal Utility District No. 50.
- 16. Website communication matters.
- 17. Maintenance of lakes and channels, including:
 - a. rehabilitation for Lake 10.
